The Dreaming of Summer Raffle is conducted by the Hanover & District Hospital Foundation in accordance with the Criminal Code of Canada, the Registrar's Standards for Gaming, and the licensing requirements of the Alcohol and Gaming Commission of Ontario (AGCO).

1. Sponsor

The raffle is conducted by the Hanover & District Hospital Foundation.

2. Ticket Sales

- Tickets are \$10.00 CAD each.
- A maximum of 2,000 tickets will be sold.
- Ticket sales begin July 3, 2026 and continue until 11:59 p.m. on August 31, 2026, or until all tickets are sold, whichever occurs first.
- Tickets may be purchased online through the Foundation's official website or in person at the Hanover & District Hospital Foundation Office.

3. Eligibility

- Ticket purchasers must be 19 years of age or older.
- Ticket purchasers must be residents of Ontario.
- Purchasers must be physically located within the Province of Ontario at the time the ticket is purchased.
- Employees, volunteers, directors and members of the Hanover & District Hospital Foundation are eligible to purchase tickets provided they meet all eligibility requirements.

A random draw will determine the winners.

The first ticket drawn will receive First Prize. The second ticket drawn will receive Second Prize.

A person may purchase more than one ticket and may win more than one prize if more than one of their ticket numbers is drawn.

Winners do not need to be present to win.

6. Winner Notification

Winners will be contacted by telephone using the contact information provided at the time of ticket purchase.

If a winner cannot be reached after reasonable attempts, or does not claim their prize within twenty-one (21) days of the draw date, the Foundation reserves the right to conduct another draw for that prize in accordance with AGCO requirements.

The Hanover & District Hospital Foundation is not responsible for incorrect or incomplete contact information supplied by a purchaser.

7. Prize Claim

Proof of age and valid government-issued identification may be required prior to the release of a prize.

Gift cards are subject to the terms and conditions established by their respective issuers.

8. Odds of Winning

Odds of winning depend on the total number of tickets sold.

If all 2,000 tickets are sold, the odds of winning any prize are 1 in 1,000.

9. Ticket Purchases

All ticket sales are final.

No refunds will be issued except where required by law.

A ticket confirmation or printed ticket serves as proof of purchase.

10. Privacy

Personal information collected during ticket sales will be used solely for the administration of this raffle, winner notification, and where permitted by law, future communications from the Hanover & District Hospital Foundation.

Information will not be sold or shared except as required for the administration of the raffle or by law.

11. Publicity

By accepting a prize, winners agree to allow the Hanover & District Hospital Foundation to use their name, municipality of residence, photograph and likeness for promotional purposes relating to the raffle without additional compensation, unless prohibited by law.

12. General

The Hanover & District Hospital Foundation reserves the right to cancel, amend or suspend the raffle if necessary due to circumstances beyond its reasonable control, subject to the approval of the licensing authority where required.

The decisions of the Hanover & District Hospital Foundation concerning all aspects of the raffle are final.
